



By-law 18-27

Being a by-law to prescribe a tariff of fees for the services offered in the Township of The North Shore.

WHEREAS Section 391(1) of the *Municipal Act, R.S.O. 2001*, empowers the Council of a Municipality to pass By-laws prescribing a fee or charge for:

1. services or activities provided or done by or on behalf of municipality;
2. costs of services or activities provided or done by or on behalf of any other municipality; and
3. use of municipal property.


AND WHEREAS The Corporation of The Township of The North Shore passed By-law 07-42 to prescribe a tariff of fees for the processing of services and By-Law 14-32 to implement tipping fees at the Municipal Landfill;

AND WHEREAS The Corporation of the Township of The North Shore deems it necessary to update the tariff of fees the municipality charges.

NOW THEREFORE, the Council of the Corporation of the Township of the North Shore enacts as follows:

1. That the tariff of fees for the processing of services be amended as per Schedule 'A' attached to this by-law;
2. That the tariff of fees established under Schedule "A" of this By-Law may be altered or new fees added by resolution or amendment to this By-Law as from time to time is deemed appropriate by the Council of the Corporation of the Township of the North Shore; and
3. That by-law 07-42 and by-law 14-32 are hereby rescinded and;
4. That this By-Law shall come into force and take effect on the date of passing.
