

#### **BY-LAW 23-78**

### THE CORPORATION OF THE TOWNSHIP OF THE NORTH SHORE

Being a By-law to amend By-Law No. 21-12

WHEREAS the Council of the Corporation of the Township of The North Shore is authorized under Section 391(1) of the Municipal Act, S.O. 2001, c.25, as amended, to impose fees or charges for services or activities provide or done by or on behalf of the Municipality, for costs payable by it for services or activities and for the use of its property including property under its control;

AND WHEREAS the Corporation of the Township of The North Shore passed By-Law No. 82-57 to provide for the management, maintenance and regulation of the water and wastewater works systems for the Township of the North Shore;

AND WHEREAS Council of the Township of The North Shore deems it expedient to amend Schedule "A" of By-Law No. 82-57, to increase rates for the Serpent River and Pronto East Water and Wastewater;

# NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF THE NORTH SHORE HEREBY ENACTS AS FOLLOWS:

1. Schedule "B" to By-Law No. 82-57 shall be deleted and amended with the addition of the following:

#### Serpent River and Pronto East Water & Wastewater Rates

Residential:

\$120.29/month

Sewer:

\$32.20/month

Commercial:

\$101.04/month

Motel:

\$240.58/month

School:

\$597.79/month

- 2. The above rates will have an annual increase of 3% for the next three (3) years (from January 1<sup>st</sup>, 2024 to December 31<sup>st</sup>, 2026).
- 3. This By-Law is deemed to have come into force and takes effect on January 1<sup>st</sup>, 2024.
