a) Minor Variance Application: To recognize the location of an existing detached garage. The garage was previously permitted to be 37.1 sq m (400 sq ft) but a 62.4 sq m (672 sq ft) garage was constructed not in compliance with the Zoning By-Law and without a building permit. The subject property is zoned Recreational Residential (R4-1) and is located on Wagoosh Lake Road. Relief is requested from Section 9.2 of Zoning By-Law 17-07 being the minimum interior side yard setback requirement of 3.0m. In this case, the existing garage is setback 2.43m from the interior side lot line. The variance requested is 2.57m.
