NEW BUSINESS

a) Minor Variance Application: 1170 Southridge Road – to permit the construction of a 30.2 sq m (352 sq ft) detached garage. The subject property is zoned Rural (RU) and is located on Lake Lauzon. Relief is requested from Section 18.2 of Zoning By-Law 17-07 being the minimum side yard setback requirement of 3.0m where as the applicant proposes a setback of 2.0m from the interior side lot line. Relief is also requested from Section 18.2 being the maximum accessory building coverage of 1% of the lot area, and the proposed garage results in an accessory building coverage of 1.3% or 74.3 sq m (800 sq ft).
