The Township of The North Shore Recreation Committee Terms of Reference (that were approved by Council on July 12th, 2023) state the following:

"6. CHAIRPERSON

The Chairperson shall be determined by the Committee and a formal resolution adopted by a majority vote to set the structure for future appointments to the position. Each Chairperson shall retain the position until their term expires, at which time reappointment or appointment of a new Chairperson shall take place.

If any vacancy in the office of Chairperson should occur during the term for any reason, the members of the Committee shall immediately elect a member to fill the position for the remainder of the said term."
