Mayor Moor update Council on the H&M COFI Broadband Internet Project. They are finalizing contract requirements with funding agencies. It is expected to close by March 2022. Construction is slated to start in the Spring of 2022. Project will provide Fibre to the Home high-speed internet to all underserved homes, businesses, and institutions in the region. Internet Services will be provided through multiple Internet Service Providers operating on the H&M COFI network, offering competitive rates for all customers. Communities and interested individuals can invest in the project, but investing is not a requirement to receiving access to the broadband network.


