e) Proclamation - Child Care Worker and Early Childhood Educator Appreciation Day

WHEREAS years of research confirms the benefits of high-quality early learning and child care for young children's intellectual, emotional, social and physical development and later life outcomes; and WHEREAS child care promotes the well-being of children and responds to the needs of parents and the broader community by supporting quality of life so that citizens can fully participate in and contribute to the economic and social life of their community; and

WHEREAS trained and knowledgeable Registered Early Childhood Educators and child care staff are the key to quality in early learning and child care programs; and

WHEREAS Registered Early Childhood Educators and child care workers will be vital to the success of the Canada-Wide Early Learning and Child Care system; and

f) National Chronic Pain Society - Opioid Crisis - Resolution of Support

RESOLUTION #23-301

WHEREAS the Council for the Corporation of the Township of The North Shore recognizes that the challenges of mental health, addictions, specifically the opioid crisis, and homelessness are complex issues that have a significant and detrimental impact on every community in Ontario; and

WHEREAS the Ontario College of Physicians and Surgeons has made a decision that will lead more people who suffer from chronic pain to turn to opioids to alleviate their pain; and

WHEREAS the College is targeting community pain clinics by requiring the use of ultrasound technology in the administration of nerve block injections by licensed physicians. This requirement will increase the time it takes to administer the nerve block and, therefore, reduce the number of patients a physician can see in a day; and

WHEREAS the Ontario Health Insurance Plan (OHIP) is proposing to reduce coverage for several vital healthcare services, including a drastic reduction in the number and frequency of nerve block injections a patient can receive; and

WHEREAS with the reduction in the number of nerve bocks being administered, many patients, looking for pain relief, will turn to overcrowded emergency rooms, opioid prescriptions from doctors or opioid street drugs;

NOW THEREFORE BE IT RESOLVED THAT Council for the Corporation of the Township of The North Shore support the National Chronic Pain Society in their request that the Government of Ontario maintain OHIP coverage for chronic pain treatments and continue to provide much-needed care for the people of Ontario:

AND THAT a copy of this resolution be forwarded to Premier Doug Ford, the Associate Minister of Mental Health and Addictions, the Minister of Health, MP Carol Hughes and MPP Michael Mantha, and the Association of Municipalities of Ontario.
